

Companions of Royal Arch Masonry in Virginia, it is with pride and sadness that this will be the last correspondence I write to you, as I am stepping down as Grand Almoner. But I must say it has truly been an honor and a

pleasure to serve you and the Grand High Priest. I would like to mention that I have seen the hard work that you have put into your "Fun Raisers", and the work you have done to obtain donations is helping find a cure for Alzheimer's. I have seen you helping our fellow Masons with your contributions to the Memory Unit at MAHOVA, and I have seen the help that you have given to your local Project Lifesaver charities. This is good work, square work, just such work that is needed for the Temple! You have impressed and awed me so much. Here are a few examples:

· You have created your own Alzheimer's Walks in Louisa and in Virginia Beach! Magnificent!

• When I receive a copy of the checks for donations to Alzheimer's, I notice that most of them come from Chapters, but many more are coming from local businesses and people that are not associated with Masonry. What this means to me is that you are talking to the community not just Alzheimer's, but about Masonry as well. Others can see the work that you are doing. And you are setting the example for the world to see!

• I have seen the many fundraising events that you have done: Table Chapters, Golf Tournaments, Dinners, Public Service Announcements, and the list goes on. Your innovation and your tenacity inspire other to do more. I do thank you!

• We have had districts that set their donation goals, raised them, and then raised them again. I would like to point out that Right Excellent Kevin McCullough and Excellent Jake Trenary, the District Deputy Grand Master and District Almoner for District 15, set their sights to obtaining \$2,500 in donations. They have raised their goals at least three times and are now at \$7,950. I do believe they will hit \$10,000!

• We have had the Rainbow Girls create their own team to find a cure and raised \$102 themselves. That may not sound like much. But, they took the challenge and in two weeks, raised money and joined me on the walk. I was sure proud to walk with them.

• District 17 has now surpassed the \$10,000 mark. But, the nice part in all of this, is that there are three other Districts on their tail! District 2 has made \$9,390 in donations, District 18 is at \$8,169, and District 15 is at

\$7,950. I know that with just a little more effort that each of these three districts will surpass that mark as well.

Grand Chapter Resolutions and Jurisprudence Committee Report Resolution #1: Proposition for amendment of sections 73 and 74

Section 73. Assignment of Chapters to Districts. All Subordinate Chapters in this jurisdiction shall be assigned to Districts, and any Chapter which may be revived, or any new Chapter which may be chartered, shall be assigned to the District to which it is geographically convenient. Be amended to read as follows:

All Subordinate Chapters in this jurisdiction shall be assigned to Districts, and any Chapter which may be revived, or any new Chapter which may be chartered, shall be assigned to the District to which it is geographically convenient. The 20th Capitular District to be excluded from consolidation with another District if it becomes necessary to consolidate the two Chapters in District 20.

Section 74. Composition of Districts. The Districts provided for in the foregoing Section shall be as Grand Chapter may from time to time determine and the Districts shall be published in the proceeding of each Annual Convocation.

Be amended to read as follows:

The Districts provided for in the foregoing Section shall be as Grand Chapter may from time to time determine and the Districts shall be published in the proceeding of each Annual Convocation. The 20th Capitular District to be excluded from consolidation with another District if it becomes necessary to consolidate the two Chapters in District 20.

<u>Reason for Resolution</u>: The reason for this exclusion is because of the geographical boundaries in which the District Deputy will have to travel a minimum distance of 200 miles round trip and have \$34.00 in tolls at the time of this resolution making it economically and geographically infeasible for the District Deputy Grand High Priest. Also, at this time the Royal Arch Chapter is the only way that the Past Master's Degree is given for the Wardens Certificate in the 12th Masonic District at this time, which would have an impact on the Blue Lodges in the District. <u>Jurisprudence Committee Comments:</u> The committee is of the opinion that Grand Chapter law should not be used to carve out a particular district for exemption. Additionally, Current law clearly states "geographically convenient" but does not address the case where it is not convenient. However, there is nothing in the law that stipulates there must be more than one chapter in a district.

Resolution #2: Resolution to Amend Section 60(f) of the Digest of the Laws, Rules, and Regulations of the Grand Chapter Royal Arch Masons in Virginia

BE IT RESOLVED, that Section 60(f) of the Digest of the Laws, Rules and Regulations of the Grand Chapter Royal Arch Masons in Virginia (hereinafter "Digest"), which reads as follows: **Section 60. Committee on Jurisprudence**. At each Grand Annual Convocation, the newly installed Grand High Priest shall appoint the following Standing Committees:

(f) Jurisprudence, consisting of five members.

Be amended to read as follows:

Section 60. Committee on Jurisprudence. At each Grand Annual Convocation, the newly installed Grand High Priest shall appoint the following Standing Committees:

(f) Jurisprudence, consisting of five members. Past Grand High Priests of Royal Arch Masons in Virginia or Past Grand Masters of Masons in Virginia who do not hold elective office in Grand Chapter; or serve as a Trustee or as a member of any committee implicating the finances of Grand Chapter, including without limitation the Committee on Finance, the Committee on the Hubard Memorial Educational Fund, and the Committee on Philanthropic Activities.

<u>Reason for Resolution</u>: According the Section 68 of the Digest, "It shall be the duty of the Committee to implement Section 34 of the Digest, reviewing all resolutions and propositions, preparing them, in collaboration with their proposers, to insure proper form, text and purpose, and to submit its findings to the Grand Secretary for presentation, in printed form, to the Grand Chapter for consideration. It shall be the duty of the Committee to further study the Digest, recommending revisions when necessary, and to update for publication in the Digest such annotations, decisions, recommendations, and laws as have been previously approved by Grand Chapter." To better effectuate the requirements hereinabove set forth, it is recommended that the Committee on Jurisprudence be comprised only of those Companions whose institutional knowledge of the laws, rules and regulations of Masonic and Capitular law derive from their past service as a presiding Grand High Priest or Grand Master. Lastly, it is believed advisable that, in order to avoid even the mere appearance of impropriety or conflict of interest, the members of the Committee should be precluded from serving on any other Committee which controls, supervises or otherwise oversees the funds, property, assets and trusts of Grand Chapter. <u>Jurisprudence Committee Comments</u>: The committee is of the opinion that this resolution is in proper form for consideration by Grand Chapter. Since this resolution directly affects current members of this committee, further comment is deemed inappropriate.

Resolution #3: Proposal for Name Change of Chapter

Section 249 of the Digest of the Laws, Rules and Regulations of the Grand Chapter Royal Arch Masons in Virginia states that when two or more contiguous Chapter deem it in their best interest to consolidate, with the permission of the Grand High Priest the consolidation may take place. In this regard, Richmond Royal Arch Chapter No. 3 and Washington Royal Arch Chapter No. 9, both located in Richmond, VA, received permission and did consolidate effective July 1, 2018. Subsequent to the consolidation, it was decided to request a name change for the new Chapter. Therefore, be it resolved that the name of the Chapter be hereafter known as Richmond Washington 3-9 Royal Arch Chapter.

<u>Reason for Resolution</u>: Both Richmond RAC #3 and Washington RAC #9 are two of the oldest Chapters in the Jurisdiction. The Chapters have played a significant role in the growth of Royal

<u>Jurisprudence Committee Comments</u>: The committee is of the opinion that precedent has been set by naming other Chapters using names and numbers they requested, and the committee sees no reason to deny this request.

The committee issued a ruling on a question from Fredericksburg Royal Arch Chapter No. 23 regarding the application for reinstatement from a member after being suspended for non-payment of dues.
